Privacy policy Zitac consulting AB

Purpose

The purpose of this policy is to inform about how we at Zitac Consulting handle personal data. Additionally, the purpose is to inform about the rights related to our handling of personal identifiable information provided by GDPR. Personal data means any information that can directly or indirectly be linked to a physical person. This can, for example, be a name, email address, or phone number. Processing of personal data includes all handling of personal data such as collection, processing, storage, and deletion.

Controller of personal data

Responsible for handling personal data is Zitac Consulting AB, org no. 556638-7139, with address Gruvgatan 39, 421 30 Västra Frölunda.

Rights of data subjects

The data subjects have a number of rights according to the General Data Protection Regulation. These rights simply mean that the data subjects should receive information about when and how their personal data is being processed and have control over their own data:

- Right to information - the data subject has the right to receive information when their personal data is being processed. Information about the processing of personal data should be provided by the controller both when the data is collected and when the data subject otherwise requests it.
- Right to correction - a data subject has the right to request that incorrect information is corrected.
- Right to erasure - data subjects have the right to request that the personal data relating to them be deleted. Data must be deleted in cases where:
 - The data is no longer needed for the purposes it was collected for
 - If the processing is based on the individual's consent and they withdraw their consent
 - If the processing is for direct marketing and the individual objects to their data being processed
 - If the personal data has been processed unlawfully
 - If erasure is required to fulfill a legal obligation
 - If data is deleted at the individual's request, the company must also inform those to whom they have provided data about the deletion.
- Right to restriction of processing - data subjects have the right to contact Zitac Consulting and in some cases demand that the processing of personal data be restricted. Restriction means that the data is marked so that it can only be processed for certain delimited purposes in the future.
- Right to data portability - the right to data portability means that the data subject in some cases has the right to receive their personal data. Data portability applies only to personal data that the data subject has provided themselves.

Personal data assistants

A data processor is a company that processes personal data on behalf of Zitac Consulting and according to our instructions. Zitac Consulting has data processors in the following areas:

- Financial services, payroll management, and invoicing

Zitac Consulting shares personal data for registered individuals with data processors in certain circumstances and in connection with the purposes and legal basis specified in this privacy policy.
